In order to verify residency within the Ewa Makai Middle School District, please provide appropriate documents showing parent/guardian/caregiver **name** and **address** (Post Office Box numbers are **not acceptable** as residence address). Documents appropriate for Proof of Residence are:

(1) Two(2) different UTILITY BILLS with parent/legal guardian/caregiver's name and address.  
(i.e. electricity or gas bill, water bill, cable bill, etc.)

**OR**

(2) Rental/Lease Agreement or mortgage statement with parent/legal guardian/foster parent's name and address at the time of enrollment and two(2) different utility bills within 30 days after enrollment.

**OR**

(3) If parents are living with relatives, the following documents are **required**:

\_\_\_\_\_ Notarized letter verifying residency by owner of property that relatives are living with and attach the owner's copy of the utility bill.

\_\_\_\_\_ Two(2) different utility bills or mailing documents with parent/legal guardian name and address.(i.e. electricity or gas bill, water bill, cable bill, monthly payroll document, etc.) within 30 days after enrollment.

I understand that this address is within the Ewa Makai Middle School district boundaries. I further understand that falsification of any information or document, either written or verbal, required for residency verification or the use of the address of another person without actually residing there may result in revocation of student enrollment. Falsification on a governmental agency application is a misdemeanor (HRS #710-1063).

The attached document(s) verifies the name and address of the person(s) enrolling the above-named student. If the individual enrolling the student is not the legal parent, court papers are required to show legal guardianship, or a notarized power of attorney (Power of attorney must not exceed one year).
